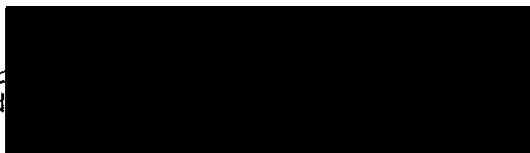
I, IAN JAMES FINDLAY
