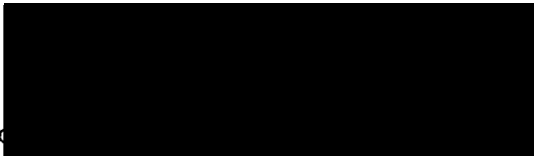
I, KATHRYN JOANNE HASLETT
